- All members must pay annual fees according to the schedule shown above. If you have played in more than one grade during the year and feel an individual ruling is required, contact the Treasurer (email: treasurer@subs.org)
- Payment can be made by credit card, cheque or cash. Credit cards will attract an admin charge of \$20.
- Goal keeping fees are negotiable if the goal keeper can substantiate expenses on their equipment to the Treasurer, Gerald Stack
- Family allowance is \$25 for the second and subsequent dependant family members
- A fee payment plan can be arranged with the Treasurer, Gerald Stack, in genuine financial hardship.
- All annual fees are considered overdue after your first game.
- If annual fees are not paid or alternative arrangements made with the Treasurer by the sixth playing date, that player shall not be permitted to play for the club in any grade. The Hockey WA will be notified on non-payment. Non-financial members are not covered by the Association's Player Insurance policies.**
- Any fees that remain unpaid will be collected by professional debt collectors.
- The Club will not provide transfer papers for any non-financial players in 2011 or 2012
- All players must recognise that their team must undertake fundraising activities. You are expected to support the team in this fundraising.

### 2011 FINES POLICY

- You agree that for Club purposes, all fines are the responsibility of the team as a whole. If your team is fined, your team can decide how to allocate any fines among yourselves as you see fit.
- You agree that any fine incurred by your team will be paid within 7 days of the Club receiving notice of the fine and transmitting notice to the team concerned. You agree that a fine incurred by your team is deemed to be a debt owing to the Club equal to the amount of the fine. This debt is owed to the Club jointly and severally by you and all other team members. You agree that failure to pay the debt owing to the Club will result in the Club barring you and the rest of your team from playing and participating in the Club social activities.

### PRIVACY POLICY

- The Club collects personal information from you for the purpose of your membership of the Club and your playing of the game of hockey or minkey. The Club will not provide personal information to sponsors or other organisations (save as required by the rules of HWA) without your prior consent. Where the Club provides information to another party, it will endeavour to always do so on the basis that the information is kept confidential. The Club will take all reasonable endeavours to keep any personal information provided to it private and confidential. You agree that the Club can provide your personal information to the office holders, employees, contractors and other volunteers of the Club for the express purpose of providing the Club services to you.
